9. The building permit fee shall be fully refunded if requested within 14 calendar days of submittal if
project does not proceed.
10. Re-roof valuation shall be calculated at \$250 per square of roof surface.
11. Zoning Permit Fee – Impervious Surface Additions (patios, sidewalks, driveways, etc.)...\$25.00

*Or the total hourly cost to the City, whichever is the greatest. This cost shall include supervision, overhead, equipment, hourly wages and fringe benefits of the employees involved.

**Actual costs include administrative and overhead costs.
